### **Meeting Notes:**

• **Existing Trail in Edwardsburg:** Add existing trail between the sports complex and the high school to the database.



- Fruit Belt Trail: Identified as active planning. Add to map.
- US-27 Route in Barry County: Verify name/labeling of this segment.
- Van Buren Trail: High impact score mentioned, with low use possibly due to the trail's surface type.
- **Berrien and Cass County:** Underinvested trail areas that are currently undergoing development.
- Blue Star Trail: Secured a TAP grant for construction.
- **Resource/Playbook for Rallying Support:** Suggested as potentially beneficial. Route Update South of Kalamazoo: Revised to Three Rivers to align with current plans.
- **Challenges in St. Joseph County:** Historical difficulties noted due to political issues and local resistance, with a missed opportunity for a rail trail in the past.
- Plainwell to Holland Connection: Advised to remain conceptual.
- Kalamazoo to Vicksburg and Three-Rivers: Verify updated routing. South of Vicksburg, update route to connect to Three-Rivers instead of Sturgis.
- **Paul Henry's Efforts in Eaton County:** Collaborating with individual property owners for connections.
- Updates to Life Stage Map:
  - Changed New Buffalo to Sawyer to Adolescence Stage.
  - Kalamazoo River Trail updated to Adolescence.
  - Pursuing updated routing of Kalamazoo River Valley Trail to Vicksburg, nearing completion.
- Follow-up Meeting with Marcy Hamilton: TGC to arrange to ensure correct trail alignments.
- Cost of Urban Sidepaths: Estimated at \$1 million plus per mile for construction.



- MDOT Ped/Bike Meetings: Cancelled; stressed the importance of sub-region meetings at least annually.
- Frequency of Sub-region Meetings: Proposed annually, in spring post-grant submissions, for sharing best practices and lessons learned.
- The City of Portage Utilization of PASER Ratings: Cited for trail maintenance prioritization.
- Meeting Materials: PowerPoint and recording to be distributed to participants.


What Trail Are You Most Closely Affiliated With? 20 responses

## What Type of Organization Are You With?




What three words best describe a world-class trail experience? 42 responses






What three words best describe a regional trail system? 43 responses
